- On receiving the development and evaluation data (*May 1* and *May 14, 2006*), the registered participant will participate in the entire evaluation in accordance with the ISCSLP'2006 speaker recognition evaluation plan (<http://www.iscslp2006.org/specialsessions.htm>) of the Special Session on Speaker Recognition, and return the system output files to CCC at mbrasser@d-Ear.com by the end of the evaluation period (*May 31, 2006*).
- The participant agrees to submit a regular paper to ISCSLP'2006 to report its system and results. The participant also agrees to be represented at an Evaluation Workshop in the Special Session to be held in Singapore on *Dec. 16, 2006* and to openly discuss its evaluation system(s) and results.
- The participant understands that, although the Evaluation Workshop is open to all wishing to participate, results are only discussed within the registered participants, that the Evaluation Workshop is open only to representatives of the registered participants, and that distribution of the Evaluation Workshop materials is limited to the attendees of the Evaluation Workshop.
- The participant agrees to not publicly compare its results with the results of other participants. Participants are free to do what they wish with their own results, but may neither redistribute nor publish results from another participant without that participant's explicit permission.
- The evaluation data, as well as all the databases namely CCC-VPR3C2005 and CCC-VPR2C2005-1000 that are to be made available to the registered participants of this Special Session upon request, are protected and cannot be disclosed, copied, or redistributed to others outside of the participant's research group.
- The registered participant is free to use the foresaid databases for research purpose only within his/her own research group, and agrees to include an acknowledgement statement containing information of Chinese Corpus Consortium (CCC) as well as its URL address (<http://www.CCCForum.org>) in the related publication(s).
